## MARCH MEETINGS

### *Connecting Government & Civil Society*

This was a busy month. We met with the National TIP Coordinator, TIP Secretariat, NPA National and DSD National to assess the relationship with Civil Society, and cover some common concerns. One result of this meeting was their decision to host the "CSO Alliance Building & Mandate Clarification" workshop. We as NFN have been tasked to draft the Concept Paper for this, and are working on consultations throughout the Network.

We also, together with the National Human Trafficking Hotline and Salvation Army Helpline, met with key senior members of the DPCI (HAWKS), Department of Justice, and National Prosecuting Authority, to discuss referral and reporting guidelines and how best the helplines can work with the Government structures already in place.



### EXPANDING KNOWLEDGE

*We are so excited at all the research taking place at the moment, it is vital in guiding the work we all do!*

*Marcel's recent article 'Child trafficking and children in South Africa's sex trade: Evidence, undercounting and obfuscations', was recently published in Child Abuse Research: A South African Journal 2020. "The research confirmed that at least 21 convictions on child trafficking could be traced so far... and thus salutes all role players, especially police officials, prosecutors and the judiciary that played a pivotal role in securing trafficking convictions to help curb trafficking as a crime of impunity."*

*A national research study has also commenced, and we are proud that four of the five from the team chosen to conduct the research, are NFN members.*

## COVID-19 RESPONSE

### *Survivor & Member Support*

Our first port of call when the pandemic and resultant lockdown struck in April, was to check in on survivors, many of whom are already some of the most vulnerable in society. To date since lockdown began, we have been able to provide support and care to 17 survivors across 6 provinces.

We also arranged discounted, as well as some free, debriefing sessions to be made available to all our Network members who felt the need to talk with someone during this time.

The "Network Needs and On Offer" initiative was successfully launched, and aims to share what we have as a Network in order to lighten the collective load. We've already had much positive feedback regarding this initiative!

We continue to network virtually, although we do miss the in-person networking a lot. We have also been taking part in many international networking calls, as all these platforms went virtual once the virus hit. It is great to be part of several global counter-Trafficking communities from whom we can learn and with whom we can share.
